<b>Welcome/Meeting Agenda/Land Acknowledgement</b>  CAP Facilitator	Alexandra Evershed, Prospectus and CAP Facilitator, and Rachel Chennette, Senior Indigenous Engagement Officer, provided an opportunity for CAP members to discuss recent news articles and provide insight from a community perspective.  Questions: 1. What exactly is changing as part of the GOCO transition?  Alexandra Evershed and Rachel Chennette mentioned they were going to try and get some of the new executives to present at the September CAP.  Rachel Chennette provided a brief update on the Near Surface Disposal Facility (NSDF) Judicial Review appeal, specifically noting how CNL's appeal seeks to obtain clarity and direction on how to navigate the changing legal landscape and regulatory environments. Rachel also provided an update on the annual Swift Night event on May 28 and discussed tariffs.
